Cancellation Policy

All registrations must be in writing. No phone registrations please. A \$50 processing fee will be charged for all cancellations received on or before March 16, 2012. A \$100 cancellation fee will be charged for cancellations received after March 16, 2012 and before April 16, 2012. No cancellations will be accepted after April 16, 2012 for a cash refund, but a credit will be issued for a future ESOP Association program, minus a \$100.00 fee per registration. The credit is good for one year from the date of the Annual Conference. No request for refunds will be accepted for separate ticketed events after April 16, 2012.

Note: The registration fee includes all convention materials and all meal functions that are not separate ticketed events. We advise that \$260 of the 2012 ESOP Association Annual Conference registration fee covers the cost of meal functions, which are subject to the 80% federal income-tax reduction limit. The remaining portion of the registration fee is fully tax-deductible.

Hotel Information

Each registrant must make his/her hotel reservations. The 2012 Annual Conference will be held at The Renaissance Washington Hotel, located at 999 9th Street, N.W., Washington, DC. The ESOP Association has

reserved a limited number of rooms at The Renaissance Washington Hotel, at the special conference rate of **\$259 Single or Double occupancy**.

To make reservations call group reservations at 1-800-228-9290 and ask for "The ESOP 2012 Room Block" to qualify for the special rate. After April 16, 2012, rooms are subject to availability. May is "**convention season**" in Washington, so please reserve your rooms well in advance.
